## STUDYING LAW

Every year over 1000 Canadian students choose to leave Canada and join a UK law school. SI-UK has over 17 years of experience helping international students apply to UK law schools and is kept up to date on the latest updates, scholarships and rankings.

Canadian students are able to study a qualifying law degree at a wide range of UK Universities immediately after high school or after they have completed an undergraduate degree.



## LLB AND NCA ACCREDITATION

The LLB is the UK equivalent of a Canadian JD. In the UK it is completed at the undergraduate level and you can apply for a 3-year LLB directly out of high school. Students who already have an undergraduate degree can complete a 2 year LLB programme.

After graduating, students who wish to practice in Canada will be prescribed exams by the NCA. Upon completion of these exams, students receive an NCA Certificate of Qualification and are able to continue with the bar admissions process.

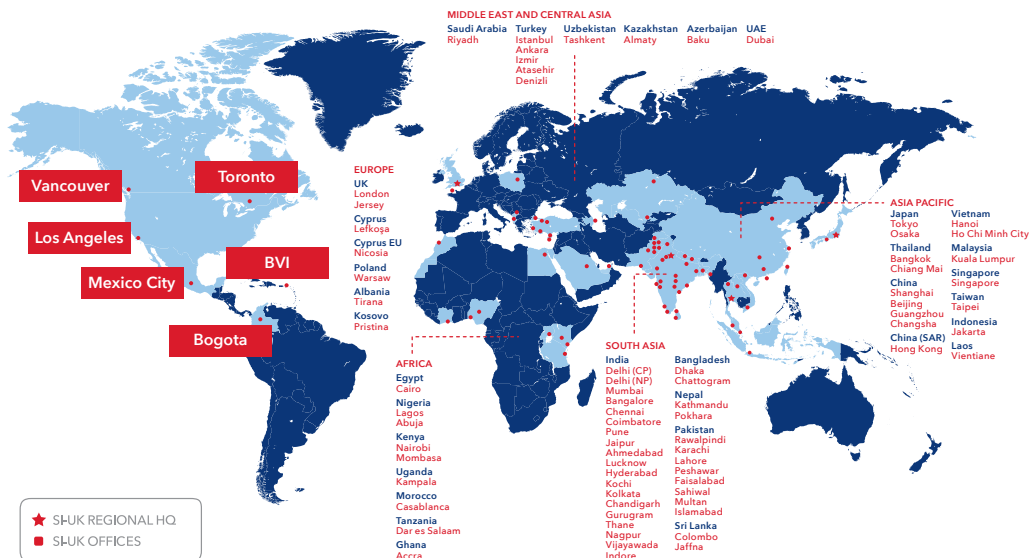
